## MEMBERSHIP

#### ASK YOUR RISK MANAGEMENT COMMITTEE

View recent questions submitted to the Risk Management Committee and their answers.

## Q: Can a Seller and Buyer agree that the EMD will not be deposited until after the inspection is waived?

**A:** Yes, but then the Buyer may deliver the check until after the inspection is waived. Once an agent has the check in hand, it must be deposited.

#### Q: What if an EMD check bounces?

**A:** A REALTORS<sup>®</sup> role as an escrow agent is a neutral role and, therefore, the REALTOR<sup>®</sup> should notify both parties if the Buyer's earnest money check bounces.

Q: The purchase agreement says that if my Buyer clients are turned down for a mortgage, my buyers are entitled to their EMD back. That is exactly what happened but the Seller objected so my broker won't release the EMD. Why isn't the contract enforced as written?

A: The purchase agreement is to be enforced as written, but the law says that in the event of a dispute, a court, not a real estate licensee, is responsible for interpreting the purchase agreement. This is true even if the correct interpretation seems obvious.

#### **Retired Vacant Land Addendum**

Your Risk Management Committee has retired the Vacant Land Addendum to Authorized Buy & Sell Agreement (VLABS). This form is no longer needed as the Committee created the Vacant Land Buy & Sell Agreement (VLBS) earlier this year. The addendum has been removed from GKAR provided e-Forms, dotloop and zipForms.

#### **Showing Etiquette**

For your safety and the safety of others, make sure you are following the showing instructions on the listing before accessing the key box on a listing.

Permission to access a property is required. Do not access a property without permission from the listing agent. This will reduce the chance of one agent being in the property and another showing up and could be a potential violation.

We've received calls from agents that stopped by their listings only to find another agent inside the property, sometimes alone, sometimes with their client.

## **KEYBOX CORNER**

• Be courteous

- Leave your business card when showing a property
- Never allow a buyer to enter a property unaccompanied
- Double check all exterior doors to ensure locks are engaged before leaving the property

#### One Photo Now Required in Flexmls

Beginning on December 19<sup>th</sup>, 2022, Flexmls will require at least one (1) photo be added to a listing in order to publish the listing. If you do not have a photo, you may use a temporary stock image. The stock image is available in the Flexmls Intranet, under **Other Files**.

As a reminder, *GKAR MLS Rules and Regulations* requires all listings to have the primary photo added within seven (7) days.
