## **MLS NEWS**

#### Photo Required to List in flexmls

Later this summer, flexmls will require at least one photo be uploaded to a listing, to be added to the MLS. You will need to have a photo of the property or may use a GKAR-provided image until property photos are available. The GKAR-provided "Photo to be Added Soon" image may be found linked on the image below or you may always find it in the flexmls Intranet.

As a reminder, GKAR MLS Rules and Regulations states that a front primary photo must be added to the MLS within seven (7) days. This means the GKAR-provided "Photo to be Added Soon" must be replaced with a front exterior photo of the property within seven days. In the event the homeowner has elected to not publish a photo of the property, you may use this GKAR-provided "Seller Declines Display of Photo" image that is linked below, on your MLS listing.





#### New Vacant Land Sales Agreement

SWMAR is currently utilizing the Supra keybox system which requires you to lease a key of your own or rely on the listing agent to access the property.

When SWMAR converts to SentriLock you will no longer need to go through these additional steps to enter a property. Now, your SentriLock access will cover all of southwest Michigan.
