# **Updated Policy on Sharing Listings**

Your MLS Committee recently updated the GKAR Rules and Regulations to align with other MichRIC® Association practices. GKAR Rules and Regulations now requires a user to receive permission from the listing broker in order to share a listing from the MLS on social media platforms.

Section 2.7 Advertising of Listing Filed with MLS: Except as specified in Section 18, Internet Data Exchange, in the MLS Rules and Regulations, a listing shall not be advertised, including on social media, by any participant other than the listing broker without the prior consent of listing broker. (Amended 05/22)

Best practices for sharing a listing include: receiving written permission from listing broker, as well as including listing broker name, and phone number, or address.

- Approved policy language that coincides with the Elections By-Law change that took effect in February

Congratulations to Drew Chapple for receiving GKAR Emeritus status.

The association receives multiple calls and emails about agents advertising properties on their social media pages and other advertising that do not belong to them or their company. MichRIC<sup>®</sup> policy allowed this even though NAR policy did not. The MLS committee drafted a new policy to no longer allow anyone to advertise another agent's listing unless they get permission from the listing broker.

Hopefully this is crystal clear. The motion passed and here is the exact language:

#### Section 2.7 Advertising of Listing Filed with

**MLS:** Except as specified in Section 18, Internet Data Exchange, in the MLS Rules and Regulations, a listing shall not be advertised, including on social media, by any participant other than the listing broker without the prior consent of listing broker. (Amended 05/22)

#### Incomplete Listings on flexmls Pro

In an effort to make it easier for you to manage listings wherever, whenever flexmls is rolling out multiple enhancements for Listing Entry and Listing Maintenance over the next few months. Their first round of updates will allow you to view and edit media, and remove incomplete listings on the flexmls For Real Estate Pros Android App and the flexmls Mobile Website (m.flexmls.com).

There will now be a menu item under the profile menu for Incomplete Listings. Here, you will be able to view any incomplete listings you have access to on flexmls desktop. You will then be able to edit or delete an incomplete listing from your mobile device. Editing will allow you to make changes to photos, documents, videos, and virtual tours.
