

Ask Your Risk Management Committee

You asked and the Risk Management Committee answered. Read recent questions submitted to the Risk Management Committee below, and previous Q & A in the <u>Bearings</u> Newsletter archives.

Q: I am a broker who only sells commercial property. Does the rule requiring 2 days to deposit earnest money in a trust account apply to deposits made in connection with the sale of commercial property?

A: Yes. The law applies to any real estate transaction and does not differentiate between residential and commercial transactions.

Q: How long should my office hold records?

A: The Rules require that escrow account records be maintained for at least 3 years. It is possible, based on statutes of limitations for various causes of action, that litigation could be initiated up to 6 years after a transaction has closed. There are also "tolling" provisions in the law that could extend the statute of limitations. Thus, while there are no absolutes, it is advisable to hold all records for a minimum of 7 years.

Q: My seller entered into a purchase agreement that contains a clause that says that the earnest money deposit will become non-refundable if the closing does not occur by the date specified in the purchase contract. The closing date has passed, but the buyer is disputing the release of the money. Since the contract says the deposit is non-refundable, can the money be released to the seller?

A: No. If there is a dispute between the buyer and the seller over the deposit, the law requires that the money stay in a broker's trust account until there is either an agreement between the parties or a court order. The fact that one of the parties' claims to the deposit is clearly wrong does not make a difference.
