- Listing Licensee Selling Broker and Listing Broker Selling Salesperson are agents for Seller; Listing Licensee and Listing Broker do not represent Buyeragents for the Seller.
- Information provided to Selling Broker and Selling Salesperson by Seller or Listing Broker shall be disclosed to Buyer and Seller have received and read the roles and responsibilities of , except as may be provided in the Buyer's Agents and Seller's Agents as described in the REAL ESTATE AGENCY DISCLOSURE OF THE GREATER KALAMAZOO ASSOCIATION OF REALTORS®Agreement.
- 4. Selling Broker has specifically rejected the position of subagent to Listing Broker on this property.
